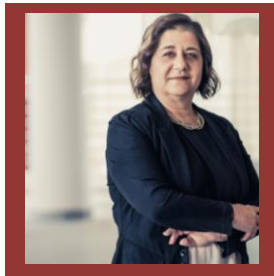

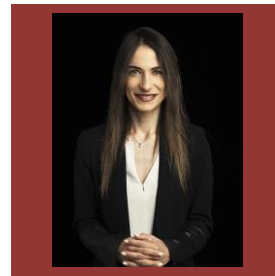

Combating Money Laundering and terrorist financing is crucial in ensuring the integrity and viability of the financial system. The proper application of Anti Money Laundering Regulations (AML) is hence crucial in ensuring that obliged entities operate to the highest possible standard.
