Unfortunately, I did not anticipate that another war would break out nine months later, significantly impacting both neighbouring countries. The situation remains unresolved, and more countries in the region are getting involved, increasing the likelihood of escalation.

In times of uncertainty, entrepreneurship is often adversely affected. However, our services have not been impacted in the same way. Cyprus can be a haven for asset protection, estate planning, and risk diversification for active businesses in the region. But we need to be selective in the opportunities we pursue.

Sanctions and adverse media are becoming more common methods of setting trends and providing guidance to markets on what to avoid. Our goal is for Cyprus to emerge as a reputable and impeccable jurisdiction where we all aspire to operate.

As for the past year, it was a year in which the Cyprus Fiduciary Association achieved its set targets. We consolidated our position as a reliable and committed stakeholder in the Cyprus economy while managing to grow during adverse conditions. Our voice is heard, and our opinion counts on all matters that affect our industry.

1. Official Meetings and Representation

Throughout the year, representatives of the Association met with government authorities, regulators, and stakeholders to discuss various issues affecting the industry and promote the interests of its members. CYFA held meetings with:

- Members of Parliament
- Ministry of Finance Officials
- Department of the Registrar of Companies
- Cyprus Securities and Exchange Commission (CySEC)
- Institute of Certified Public Accountants of Cyprus (ICPAC)
- Cyprus Bar Association (CyBAR)
- Cyprus Chamber of Commerce and Industry (CCCI)
- STEP Cyprus
- Cyprus Investment Fund Association (CIFA)
- Invest Cyprus
- Cyprus International Business Association (CIBA)

2. Public Consultations / Position Papers / Ad-Hoc Committees

The Association as part of its overall efforts to promote and protect member's interests has participated in various public consultations and has submitted relevant positions:

Banking Sector:

The Association held a meeting with the Association of Cyprus Banks (ACB) to exchange views on various matters faced by the ASP industry regarding banking practices and procedures. During the meeting, the Association had the opportunity to comment on the limitations and the challenges posed to the industry due to the implementation by banking institutions of a stricter AML/FT regulatory framework, enhanced client onboarding procedures, and a widely adopted de-risking strategy. Additionally, CYFA is part of the Ad-Hoc Working Committee formed by the Central Bank of Cyprus to discuss issues faced with banking procedures and to identify possible improvements.

EU 'Unshell Directive":

In relation to the draft Council Directive laying down rules to prevent the misuse of shell entities for tax purposes and amending Directive 2011/16/EU (the Directive), published in December 2021 by the European Commission (EC), the Association throughout 2023 actively engaged in the consultation process initiated by the Ministry of Finance and collaborated with key stakeholders to identify the key challenges and make relevant proposals.

UBO Registry:

CYFA actively engaged and communicated industry concerns to the relevant government authorities and managed to identify viable solutions to the issues that arose with the implementation of the UBO Registry final solution phase.

Cyprus Tax System Reform:

CYFA is part of the ongoing consultation process and is in contact with key industry stakeholders to ensure that any proposed tax regime will be for the benefit of the industry and the economy as a whole.

RBSF-ASP's Form Version 6 (CySEC):

Throughout 2023, the Association engaged in a productive consultation process with CySEC, whereby industry feedback and concerns were provided to assist in identifying solutions to various reporting issues faced by members while providing accurate statistical information. Numerous CYFA recommendations were adopted by the Regulator as communicated to members through relevant industry announcements.

FDI Screening Law Framework:

During 2023, CYFA continued to consult with stakeholders regarding the enactment of a law that establishes a framework for screening foreign direct investments. This law aims to apply specific provisions of Regulation (EU) 2019/452 of the European Parliament and of the Council of 19 March 2019.

Trust Registry (CyTBOR System):

After the launch of the CyTBOR system in 2022, CYFA and STEP Cyprus worked together to provide CySEC with recommendations on how to improve the system's efficiency and functionality. We are happy to report that many of our suggestions have been accepted, while a few others are still being considered.

EU/US Sanctions:

Throughout 2023, CYFA has been actively consulting with the Ministry of Finance and relevant key industry stakeholders to identify key issues and ensure the smooth application of restrictive measures related to the sanctions being imposed on Russia. The Association also participated in relevant Parliamentary discussions related to the impact of US sanctions on the industry. The aim was to identify possible measures that would assist the industry in addressing the challenges faced.

Amendment of The Companies Law:

CYFA participated in the consultation process initiated by the Department of the Registrar and Intellectual Property Rights regarding the proposed amendment of The Companies Law. The amendment aims to harmonize it with Directive (EU) 2019/1151 of the European Parliament and of the Council of 20 June 2019, which amends Directive (EU) 2017/1132. The amendment focuses on the use of digital tools and processes in company law.
