Speaker Bio

Stella Kammitsi

Stella Kammitsi is a qualified lawyer and a member of the Cyprus Bar Association since 1992. She is the founder of her own law firm and is the owner and Managing Director of Raza Corporate Services Ltd, a corporate and fiduciary service provider regulated by the Cyprus Bar Association.

Her legal practice focuses primarily on Corporate Law, Banking, Trust and Estate Succession Planning, and Commercial Law. She began her legal career at Chrysafinis and Polyviou LLC, where she initially handled a wide range of litigation matters. She later became Head of the firm's International Corporate Department, advising on international corporate sales and transactions, joint ventures, cross-border mergers, and finance transactions, including syndicated loans and securities.

Stella has also served as external legal counsel to an international banking unit in Cyprus and has advised numerous international companies operating in Cyprus.

She currently holds the position of one of the Deputy Chairpersons of STEP Europe and is the former Chairwoman of STEP Cyprus. In addition, she served as Vice-President of the Business and Professional Women Association (BPW) Cyprus and has held roles as Chairperson of the Standing Committee for Legislation of BPW International, Chairwoman and Vice-Chairwoman of the Housing Finance Corporation of Cyprus (by appointment of the Council of Ministers), and President of the Cyprus Women's Lobby.

A frequent speaker at both local and international conferences, Stella is also actively involved in co-organizing major international events in Cyprus in collaboration with the Cyprus Chamber of Commerce and Industry.

She is currently a lecturer at the International University of Monaco and has also taught Business Law and Banking Law at various universities and colleges in Cyprus.

Stella earned her LLB (Honours) from the University of Leicester in 1990 and her LLM in International Banking Law from Boston University School of Law in 1991. From 2015 to 2018, she was listed for five consecutive years in Citywealth's IFC Powerwomen Top 200.
